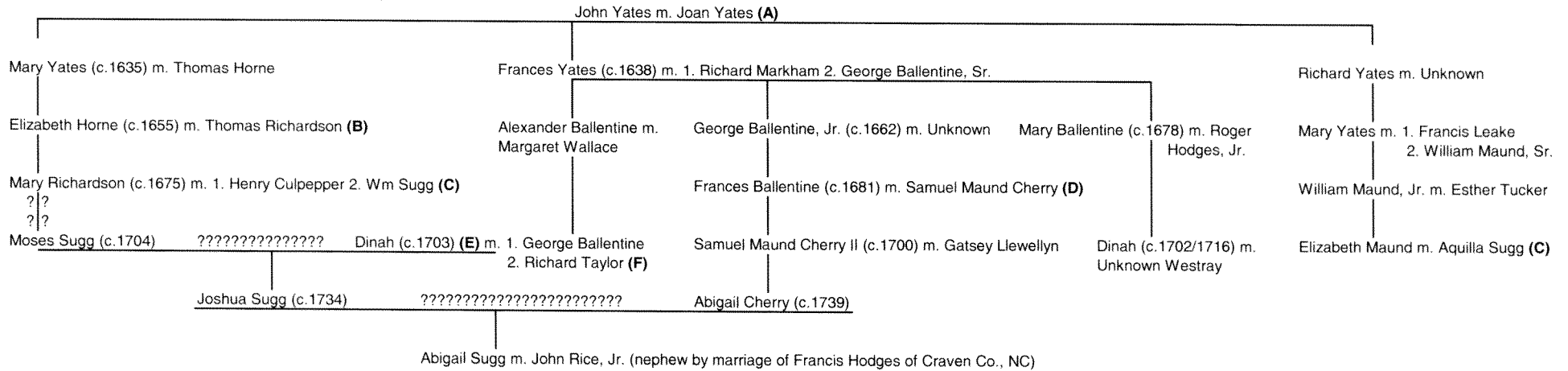


Norfolk County, Virginia Families (Not Verified) - CHART I
Including Hypothetical for William Sugg Family



Dinah (E) - Is she daughter of Richard Wallis & Judith Etheridge?

- (A) John Yates & Joan Yates had another daughter named Joan. I didn't find information about her on the internet. However, it is interesting to note that Godfrey Spruill's wife was named Joan who could possibly be about the right age. Godfrey Spruill had a granddaughter who married Matthew Caswell, Jr. whose father sold land to William Sugg in Norfolk Co., VA in 1693 (Matthew Caswell, Sr. married a daughter of John Bigg). Further, another daughter of Godfrey Spruill named Anna Margerita or Henrietta married Samuel Boutwell and they were the parents of Burtonhead Boutwell who married Elizabeth Commander, sister of Samuel Commander who sold land to Joshua Sugg in Johnston Co., NC in the 1750's (a niece of Burtonhead Boutwell named Jemima married Griffen Floyd and one of the witnesses of the will of Samuel Maund Cherry II was Griffen Floyd). Comment on John Bigg who left will in Norfolk County, VA in 1694: He may have had children or grandchildren who migrated to Craven Co., NC. Witnesses for John Bigg's will include John Portlock, Thomas Nash, Thomas Etheridge, Joseph Hodges, Rebecca Hodges, William Maund, and William Etheridge. Was Thomas Etheridge father of Marmaduke Etheridge who married Elizabeth Yates, who was sister-in-law of William Maund, Sr.? Did Thomas Etheridge have cousin John who married Eleanor Bright (connected to Craven Co., NC Bright family)?
- (B) Thomas Richardson may have had sister (or aunt?) Lydia who married John Manning. John Manning & Lydia Richardson were parents of Margaret Manning who married Richard Taylor, Mary Manning who married Roger Hodges, Sr., and John Manning who married Sarah Watford. Did Roger Hodges, Sr. have a previous marriage? Was he father or uncle of Roger Hodges, Jr. who married William Ballentine? How are the Hodges of Norfolk Co., VA related to Francis Hodges of Craven County, NC?
- (C) William Sugg of Norfolk Co., VA was born c. 1660 and was married first to Ruth Fenford, and secondly to Mary who is mentioned in his 1704 will (Division of Estate 1708). I think Mary is actually Mary Richardson based on circumstantial evidence found thus far. William Sugg had brothers Joseph and George. George Sugg was the father of Aquilla Sugg who married Elizabeth Maund -- Aquilla Sugg was prominent in Edgecombe Co., NC. I think Aquilla Sugg's second wife was Abigail Bonner.
- (D) Samuel Maund Cherry was the son of John Cherry, II and Rebecca Maund. Not sure how this Rebecca Maund was related to William Maund, Sr., but assume she was either a sister, cousin, or niece.
- (E) Dinah who married 1. George Ballentine and 2. Richard Taylor may be the daughter of Joseph Watford (also spelled Wotford, Wafford, Wofford, etc.). She could also be the daughter of Richard Wallis who supposedly married Judith Manning. She is not the daughter of Roger Hodges & Mary Ballentine who married a Westray. There is also a Dinah Herbert, but she married a Simmons and left a will in Wake County, NC (which was witnessed by Joel Lane) - Dinah Herbert had a sister Mary married to Thomas Sugg, grandson of George Sugg. The reasoning for thinking Dinah who married second to Richard Taylor is a Watford is due to her assigning power of attorney to Joseph Watford for the estate of George Ballentine in 1723. Then, she administered the estate of Richard Taylor in 1734 in Norfolk County, VA and later we have Dinah Taylor ("of VA") selling 640 acres of land in Bertie Co., NC to Joseph Watford. Wotfords were related to Mannings who are related to Taylors, so there's a connection here. The question is whether she could possibly be the same woman who was mother of Moses Sugg's children...namely, Joshua, Mark, Aaron, William, and Moses, Jr. Supposedly, there was a Sugg/Taylor daughter who married Unknown Sevils as well. Interestingly, there is a Courtney connection to an early Sevils in Norfolk Co., VA, which may connect Cherry with the Sevils surname (in Wake County, Courtney Sevils married Martin Lane). We also have will of Solomon Sivils in Norfolk Co., VA which lists two sisters who married Hodges. Comment on the name Mark: I cannot figure out where this name is originating unless it's an abbreviated version of Markham or Marcum. I think John Manning who married Sarah Watford had a son also named John who married a Marcum. Could John Manning (Jr.) and Unknown Marcum actually be the parents of Dinah who married 1. George Ballentine and 2. Richard Taylor? This John Manning (husband of Unknown Marcum) died c.1715..perhaps Joseph Watford was guardian for his children?
- (F) Richard Taylor, a grandson of Richard Taylor & Margaret Manning, married Dinah whose maiden name is unknown. Richard Taylor & Dinah had a son named Joseph born c. 1730 who married Nancy Cherry (and they had a grandson named...Markham). Another grandson of Richard Taylor and wife Dinah was named John who married a daughter of Samuel Maund Cherry (3rd) and Unknown Moore. Samuel Maund Cherry (3rd) would have been the brother of Abigail Cherry who could possibly fit as wife of Joshua Sugg. They were children of Samuel Cherry (2nd) who was married twice: First to Mary Courtney and second to Gatsey Llewellyn (daughter of Capt. George Llewellyn, according to the internet). Samuel Maund Cherry (2nd) died in 1754 in Beaufort Co., NC, but his land later became part of Pitt Co., NC. Another of Samuel Maund Cherry's daughters married John Hodges, and it appears John Hodges & Rebecca Cherry moved to Craven Co., SC, which is where Burtonhead Boutwell & Samuel Commander lived. Samuel Maund Cherry II appears to have lived in same vicinity of Beaufort/Pitt Co., NC as Samuel Boutwell, brother of Burtonhead Boutwell. Final Comment: Richard Taylor had great-grandson named Markham Taylor...does this tie them back somehow to Markham family knowing that Markhams were connected at least with Manning and further back to Ballentine as well. Is surname "Markham" the origin of the abbreviated first name "Mark?" One more comment for Markham: I noticed one Rootsweb posting that links a John Markham as possibly being the identity of the pirate Blackbeard.

NOTE: Spouses for William Sugg, Moses Sugg, and Joshua Sugg are speculative. It is known that William Sugg's first wife was Ruth Fenford, but all that is known of his second wife is that her name was "Mary." Moses Sugg had children with Unknown Taylor. Some believe this to be her maiden name, but it may have been a widow Taylor. A possible candidate could be Dinah (possibly Watford or Manning) who first married George Ballentine and then married Richard Taylor who died c.1734 (according to internet family trees). Joshua Sugg's wife was Sarah, but there was an early deed in Johnston Co., NC with witness "Abigail Sugg." For some reason, the birth year for Abigail Cherry has been assigned as 1739 by some Cherry family researchers (not sure how they arrived at that date), which happens to be the same year of birth for Sarah Sugg according to 1814 obituary in the Raleigh, NC newspaper. as follows:

Hendrickson ©1988 © 2007 Revision: Sarah (Sally) Sugg's death is recorded in both the Raleigh Star Newspaper and the Raleigh Register Newspaper. They state in the 23 December 1814 issues that on the 14th (December) at the seat of Mr. Joshua Sugg, Senior near the City of Raleigh, Mrs. Sarah Sugg, wife of said Joshua Sugg, aged 75 years, who had been his companion for 58 years and who lived 12 days without any kind of food to support nature, had died. To be 75 in 1814, Sarah Sugg was born circa 1739. They married around 1756 probably in Johnston County, North Carolina. No record of the marriage has been found
